-42: Learn from the error of my ways

Error -42: Too many files open.

I can't tell you how many times that error message popped up on my Mac. I *can* tell you how close I came (very) to ramming my fist through my monitor every time my computer

would lock up or I couldn't save a document because "too many

files open." I began to think of -42 as my own personal curse — a computer version of the Satanic "666" mentioned in the Bible.

Mac error codes are notoriously unhelpful in that they don't really *tell* you anything. Even utilities that list error code explanations offer very little in addition to the error code number. In my case, looking up -42 revealed the following: Too many files open. Oh, *really*?

Like me, you'd probably assume that closing a few files would eliminate the problem, right?. Nope, the error occurred when I had no applications or files open on my computer at all. Nada. Zip. *Nothing*. When I started to open my first file, the error popped up. Apparently one file was too many.

Next, I went to the Apple website in search of their explanation of -42. After several searches using different criteria, Apple's website offered the following helpful information: Too many files open. That was it. The error disappeared if I "shiftstarted" my computer to turn off all extensions and control panels. But then, *most* software problems disappear if you turn off virtually everything except the System and Finder. However, it did confirm it was a software problem, not a hardware

The solution to "Error -42: Too many files open" depends on how you define "files." t a hardware problem. Sometimes a loose or damaged cable—

internally or externally—wreaks havoc on a Mac in unexpected ways. Not this time, though.

With software the culprit, I ran my trusty copy of Conflict Catcher to track down the potential problem in the hodgepodge of system extensions and control panels that are a part of any Mac. Despite several hours of tedious comparisons of various startup

sets, the error persisted.

I created a minimal startup set using only those items I needed to complete my project. In other words, I turned off everything that was either fun or superfluous, stripping my Mac down to a very basic configuration.

The problem persisted.

I ran Apple's Disk Utility, Norton Utilities, Norton Anti-Virus, TechTool Pro and DiskWarrior. All these "we can fix anything" utilities analyzed and fixed minor errors and directory glitches.

The problem persisted.

Then I tried what I usually try once I calm down and the steam stops shooting out of my ears like a Warner Brothers cartoon character. I tried to retrace my steps, computer-wise, to track down when the problem started. *Continued on page 4*

SIG Coordinator David Scheuer reported that he has been unable to get in touch with Larry Mcloughlin and isn't sure about the

Internet SIG. Jonathan Magnus will be starting up a JavaScript SIG. Filemaker Pro SIG will check out the brand-new version 5.

Volunteer Manager Peter Gingiss was absent and no report was given.

Apple/Mac Librarian Mike Brouillette was absent and no report was given. There was some discussion and an approved motion for Mike to pick up a monitor, but after further discussion Jeff said he had a bunch of monitors that Mike could dissect to make a functional one.

Publicity Chairman Kimberly Reeves was absent and no report was given.

Boutique Chairman Amy Denton reported about \$147 earned in September and August. She did buy a new cart and will try to get to meetings earlier.

OLD BUSINESS

USB storage options starting to hit the market

CD RW and Travan backup drives offer ease of use and low prices with only a few snags

USB mass storage and backup solutions are beginning to hit the market. Imation and Iomega brought out USB products just after the introduction of the iMac and Blue-and-White G3. Now there are external hard drives, CD RW drives, and a Travan tape drive, which was introduced in August.

When backing up my B/W G3 to Zip disks became tedious and timeconsuming, my first thought was to buy the QPS Que! CD RW drive and backup to CDRs. However, after purchasing the unit I found that Retrospect would not recognize the drive. Rumor has it that Dantz may release a Retrospect driver for the drive; it supports a similar unit from Sony.

The QPS Que! Drive writes data at 4x to CDR disks and 2x to CDRW disks. It will also write audio tracks at 2x. The unit will read data at 8x. The 4x will only work if the unit is connected directly to either the iMac or B/ W G3; 2x is as fast as it will write when connected through a USB hub.

The drive is color coordinated with the original iMac or a B/W G3, and comes packed in a very nice carrying case with "line lump" style power supply and a USB cable. It is also bundled with Adaptec's Toast (Ver. 3.8) software for burning CDs.

As with all USB peripherals, installation is easy—plug in the power supply and USB cables and load the drivers. I can't say I was successful right out of the box, but the problem was operator failure and not the drive. After reading the drive manual and the Adaptec manual I was successful after making only two CD "coasters."

After reading the drives manual, I found the part about the speed limita-

tion when going through a USB hub. The manual also states that the driver will not play music CDs, even though it has a mini headphone jack on the front and RCA phono jacks on the rear that would feed a stereo. A new driver is still not available.

Likes: Design: It coordinates with my computer, and the carrying case is very nice.

USB, while not as fast as SCSI, is what I have without buying a PCI SCSI card.

Power supply: This is a "line lump" and not a "wall wart," so it will not cover power jacks on your plug bar. The case has pockets to keep the cords under control when traveling. Below \$300.00. Enough said!

Dislikes: Will not play music CDs. I hope the driver will come soon.

Will not write at 4x if connected through a USB Hub. This can cause a real problem if you have other USB equipment and a USB keyboard, which must be connected directly to the computer if you want to use the keyboard power on button.

Adaptec Toast locks up the computer when there is an error.

I think the likes and the dislikes balance out. The one major feature is the price. Other USB CDRW units cost more than \$300.

The original reason for my purchase of the QPS Que! Drive was a bust, but Aiwa recently released a Travan backup tape drive (TD-U8000 that uses the TR 4 cartridges (4-Gigabyte) for backing up. The unit comes with Retrospect 4.1 with a USB driver for the unit. It does one thing, backing up data, and it does it very well. The Aiwa drive theoretically can write eight Gigabytes of data to a TR 4 cartridge depending on a software

data compression ratio of 2:1.

The version of Retrospect supplied was customized to take advantage of the TD-U8000. But other than driving the tape drive, it is the latest version of the popular backup utility. The installation CD is bootable and has Apple Disk First Aid, and HD Setup and an unpacked version of Retrospect. This will allow you to recover from a major hard disk failure.

If you've used Retrospect, you know that making backups is an easy process. The program is fully scriptable, so you could make backups automatically.

My first full backup took about an hour and a half. The drive wrote data at about 20 Megabytes per minute. The time also included the verification step.

I can compare this unit to an AST unit that I have at my office. The Aiwa unit is noisier because it has a cooling fan, which the AST unit did not. The AST unit is a SCSI device, so the writing speed was in the 45-50 Megabytes per minute. The Aiwa unit costs approximately \$250, and the AST drive was over \$500.

Likes: About \$35 per cartridge for four Gigabytes. I doubt that I will need many cartridges.

The unit has an attached 110-power cord, no line lumps/wall warts.

Worked first time out of the box.

Dislikes: The unit is noisy, I doubt that you could sleep while it was running if it was in your bedroom.

No driver available to allow the drive to mount on the desktop to be used as a normal storage volume.

If you want to add specialty storage to your USB-equipped computer, these two products should be given some consideration. Both worked well.

Error -42 Continued from page 1 If I don't have a computer problem one day and I do the next, something is different. And it's usually something I've done to the computer, like install new software.

So I started to think (about time, I'd say). My project involved graphics files from dozens of different sources. all of which came with associated fonts. I'd activated the fonts using Suitcase, a handy font handling utility finally available in a System 8x-compatible version. I didn't see how fonts could be the source of the error. though, because I keep a lean set of permanent fonts and I hadn't activated that many fonts in addition to my standard set.

Then I had the "aha."

When I installed Suitcase 8 a few weeks prior to the big project, I ran a utility now included with it called "Font Agent." This utility is supposed to solve all font woes, resolve font ID conflicts, reorganize your font suitcases, polish your silverware, etc. So I ran it and let it do its "thing" using the default settings and never giving much thought to what it actually did.

HAAUG members can donate-and buy-used software and hardware by bringing it to the monthly meetings. Here's how it works:

Incoming donations

- Items are non-deductible donations to the club and all proceeds go to the general treasury.
- Make them very inexpensive or they won't sell. Old floppies and obsolete software don't seem to sell at all.
- If it's sizeable or valuable, the best route is usually the silent auction. **Items for sale**
- Silent auction items: the winner is the high bid at 12:30 PM when the 12:30 PM SIGs start. The item should be picked up then or as soon as practical after 12:30.
- Priced items unsold are up for grabs at 12:30. If you see something you can use and it's not worth the price marked, take it and donate whatever you feel appropriate to the club, even if it's a quarter.
- ٠
 - Stuff still undisposed of at the close of the 1:45 PM SIGs is usually trashed. No one wants to carry it home again and back next time.

Apparently, one of the ways Font Agent solves font problems is by breaking down all font families into their smallest component parts. Whereas before I had one font suitcase containing all the various Helveticas, now I had several containing the different flavors of Helvetica (narrow, condensed, compressed, Helvetica Neu). Multiply that by a few font families. Instead of a few font suitcases, I now had dozens and dozens of small font suitcases. all active at the same time.

I hadn't just added a few font cases to the few I thought I had open. I'd added a few to the more than 100 font cases Font Agent automatically created for me to solve my font problems. (Obviously, I would not recommend using the default settings in Font Agent.)

Time for "aha" number two.

The Mac sees everything that opens upon startup, including extensions, control panels and fonts, as files, and there is a limit: 346. That number comes from information provided by "Black & Bleu," a software package that analyzes Macintosh error codes. You can download it from http://www.bleurose.com/. Black & Bleu confirmed what I had started to suspect. Fonts were at the heart of a problem I thought I had solved ages ago by collecting my standard fonts into a few suitcases. Font Agent undid my handiwork. Adding fonts for the big project pushed me over the open file limit into Error -42 hell.

The solution: turning off every single font I didn't absolutely need and combining the rest into a few font suitcases. The trick is that you can have many fonts in a suitcase, but the Mac sees the case as a single file. If you don't have a font handling utility like Suitcase or MasterJuggler, you can easily create empty font suitcases with "Fast Case," shareware available at http://www.macdownload.com.

So if the dreaded "-42: too many files open" message pops up on your computer, remember: the Mac sees everything that opens on startup as a file, but it sees a font suitcase with many fonts inside it as a single file. Combine your fonts into fewer suitcases to avoid "font bloat" and -42. Learn from my pain. I've suffered enough for both of us.
