




Cool Feature of Tiger Mail

Checking your imap quota via Mail

I stumbled across this feature of Tiger's Mail app this past weekend. If you select your inbox and do a command-i (a.k.a. Get Info) you can look at your email account imap quota. If you've ever gotten a notice from your email admin that the size of your mailbox is out of control, this is the tool that will help you regain control.



I used it this weekend to clean up some of my imap accounts (my .Mac account was at 50% before I moved stuff to my local hard drive). You can toggle between accounts in the window, once it's open. If you move mail from your server to a local mailbox, you'll have to restart Mail to reset your account and see the change.

So mark your calendars now so you won't miss the 2006 HAAUG MacFest. Check www.haaug.org frequently for more details.






